This **MEMORANDUM OF UNDERSTANDING** (hereinafter referred to as “**MOU**”) is made and entered into on this 14th October 2022 between, the **Association for Sustainability in Building and Environment** (hereinafter referred to as “**ASBE**”), whose address is Office No. 5, Bandekar Building, Near Bank of India, Kaziwada, Ponda - Goa. 403 401, duly represented by Ar. Yatin Kandolkar, President, Association for Sustainability in Building and Environment, of the **FIRST PART** and **Goa College of Architecture** one of *Government of Goa's* technical education institutes, located at Dr. T. B. Cunha Educational Complex, Altinho-Panaji, Goa, 403001 (hereinafter called “**GCArch**”) duly represented by Dr. Ashish K. Rege, Professor and Principal, Goa College of Architecture, on the **OTHER PART** (who for the purpose of this MoU are hereinafter individually referred to as ‘**PARTY**’ and collectively referred to as ‘**PARTIES**’);

AND WHEREAS **ASBE**, which was established in the year 2021 with the aim of unifying the diverse group of sustainability professionals under one umbrella so as to promote learning that transforms human behavior from unsustainable to sustainable practices, in accordance with the diverse contexts in which Indian settlements exist.

AND WHEREAS **GCArch**, is a premier institute in Goa imparting education in the domain of Architecture since 1982, and has pioneered establishment of a post graduate programme named Master of Architecture in Sustainable Habitat, with the aim of training professionals with the skills required for effectively participating in the National Mission for Sustainable Habitat;

Now, therefore, in consideration of the premises and mutual covenants hereinafter contained, the parties hereto agree as follows:

- a. GCArch will collaborate with ASBE in achieving its goals and objectives of making people aware of the context specific best practices that need to be adopted in order to achieve various targets identified as part of the 17 Sustainable Development Goals and its importance for human well-being.
- b. In order to fulfill the above goals and objectives of complementary collaboration, GCArch will conduct various training programmes, seminars, awareness drives, rallies, street plays and such other activities through its ASBE Cell.
- c. GCArch will provide logistic support & student volunteers for the programmes.
- d. ASBE will provide support to the programmes organized by GCArch as well as share the knowledge and expertise of each other's constituents.
- e. The members of ASBE Cell of GCArch can collaborate with ASBE in their field work and/or research work as and when mutually decide.

1. BENEFIT SHARING:

GCArch may organize Sustainability related awareness programmes in turn; ASBE will provide human resource for the programmes. Both the parties will thereby be mutually benefitted in their respective objectives of creating awareness on Sustainable Best Practices in the domain of Building and Environment.

2. TERM AND TERMINATION OF MOU

This MOU is effective upon the day and date on which it signed and executed by the duly authorized representatives of the parties to this MOU and shall remain in full force and effect for a period of 3 years. Review meeting between the parties will be held once in a year. This MOU may be terminated, with cause, by either party upon 30 days written notice, which notice shall

be delivered by hand or by certified mail to the addresses listed above. The MOU may be modified or amended at any point of time by written agreement between the parties.

3. IN WITNESS WHEREOF,


the parties to this MOU through their duly authorized representatives have executed this MOU on the day and year hereinabove mentioned, and certify that they have read, understood, and agreed to the terms and conditions of this MOU as set forth herein.

This MoU has been executed in two originals, one of which has been retained by ASBE and the other by GCArch.

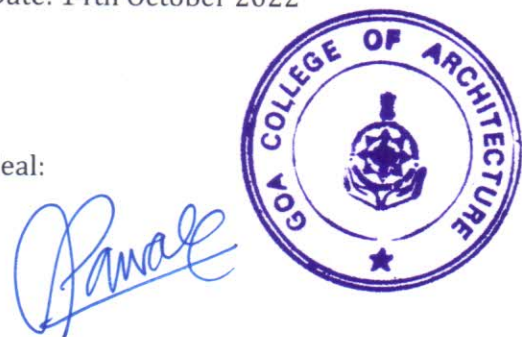
